PART 1 HISTORY, VISION, MISSION, AND OBJECTIVES

1.1 Brief History of The Study Program

The Faculty of Health Sciences was established in an effort to meet the need for higher education in accordance with the demands of society. The State Islamic University (UIN) Syarif Hidayatullah Jakarta opens new departments and study programs to support the development of UIN in integrating scientific, Islamic and Indonesian aspects.

The opening of the Faculty of Health Sciences began with the holding of the UIN Syarif Hidayatullah Jakarta Senate meeting on December 30, 2002 by considering the importance of opening a new study program in the field of Health. The forum has recommended the establishment of the Faculty of Medicine and Health Sciences (FMHS).

The establishment of FMHS was initially intended to answer challenges in realizing the concept of Healthy Indonesia 2010 proclaimed by the government which required more nurses (Ners), pharmacists and public health. This is in accordance with UIN's vision, which is to make UIN Syarif Hidayatullah Jakarta a leading higher education institution in integrating scientific, Islamic and Indonesian aspects.

Based on the decision of the Senate, the preparation of proposals for four Study Programs under the auspices of the Faculty of Medicine and Health Sciences was initiated, namely Public Health, Pharmacy, Nursing science and Medicine. The team for preparing the proposal for the establishment of FMHS was chaired by Prof.Dr.(hc), dr.M.K.Tadjudin,Sp.And. from the Faculty of Medicine, University of Indonesia who also acted as the Faculty of

Trustees at that time. The initiators of the establishment of FKIK at UIN Syarif Hidayatullah Jakarta were Prof. Dr. Azyumardi Azra, MA., Prof. Dr. Suwito, MA, Prof. Dr. Abuddin Nata, MA, Drs. H. Achmad Gholib, MA and Drs H. Abdul Shomad. The team for drafting the Nursing Science Study Program proposal was chaired by Mrs. Tien Gartinah, MN.

The Nursing Study Program began with the issuance of a Decree from the Directorate General of Higher Education, Ministry of National Education of the Republic of Indonesia number 1356/DT/2005 dated May 10, 2005 and a Decree from the Director General of Islamic Religious Institutions, Ministry of Religion of the Republic of Indonesia number DJ/II/123/2005 dated May 17, 2005.

In 2018 the Faculty of Medicine and Health Sciences was divided into the Faculty of Health Sciences and the Faculty of Medicine based on the Regulation of the Minister of Religion of the Republic of Indonesia Number 1 of 2018 dated 23 February 2018 concerning the Second Amendment to the Regulation of the Minister of Religion Number 6 of 2013 concerning the Organization and Work Procedures of the Syarif Hidayatullah State Islamic University Jakarta Rector's Decree Number 129 of 2003 concerning Organization and Work Procedures, Statutes and Job Descriptions of the State Islamic University (UIN) Syarif Hidayatullah Jakarta and Decree of the Chancellor of UIN Syarif Hidayatullah Jakarta No. 141a of 2018 dated 26 February 2018 regarding the closing of the Faculty of Medicine and Health

Sciences and the opening of the Faculty of Health Sciences and the Faculty of Medicine of UIN Syarif Hidayatullah Jakarta.

The Faculty of Health Sciences continues to strive to expand its network of collaborations with various hospitals to support the clinical practice learning process for its students. The network hospitals we utilize as facilities for clinical learning include: The Fatmawati Center Education Hospital, designated as the Main Teaching Hospital, along with Marzoeki Mahdi Hospital, the Regional General Hospital (RSUD) of Tangerang Regency, Jakarta Hajj Hospital, Darma Graha Serpong Hospital, Pasar Minggu Hospital, and South Tangerang Hospital, which serve as network hospitals. This collaboration also involves the DKI Jakarta Social Service and the South Tangerang City Health Service. To date, the nursing science study program has produced graduates who have successfully disseminated their expertise both domestically and internationally.

1.2 Vision, Mission and Objective Study Program

To become a center of excellence in Nursing Science Study Programme that integrates nursing science with Islamic values and competes effectively at the national and global levels.

Semester 1	
Become an Islamic Nursing Student	Through the module to become a Muslim nurse student, students will have competence in the fields of adult learning, Islamic stress management, reference search, as well as how to study at PSIK FIKES UIN Syarif Hidayatullah, and mastery of technology that supports learning based on Islamic principles and values including etiquette in seeking knowledge
Nursing Philosophy and Theory	Discusses the philosophy, paradigm, and conceptual models and theories of nursing from both a general and Islamic perspective, the principles of a holistic approach and the practice approach of Muslim nurses in the

	context of nursing
Basic Nursing Concepts	This course discusses the basics of being a Muslim nurse, health and health professions from an Islamic perspective. This includes concepts discussed <i>caring</i> throughout the human life cycle, the concept of human growth and development, professional standards in practice in nursing practice including nursing ethics and legal aspects in nursing practice both at home and abroad, including IPE and IPC by integrating Islamic knowledge in each topic of discussion.
Basic Biomedical Sciences	This course is part of a group of sciences which discusses the concepts of biology, physics, biochemistry, nutrition by paying attention to the environment and scientific ethics, as well as concepts of human anatomy and physiology in maintaining body homeostasis which integrates qauliyah and kauniyah verses in each discussion
Islamic Studies	Islamic studies courses discuss the meaning, origins, types, elements and functions of religion for human life; understanding of Islam, characteristics, similarities and differences with other religions, sources and main points of Islamic teachings. This course also discusses aspects of Islamic teachings regarding worship, spiritual and moral training, Islamic history and culture, politics, education, da'wah, society and gender equality in aspects of Islamic teachings, contemporary issues regarding Islam's contribution to the civilization of the Islamic world. In this course, the Interprofessional Education learning method is applied, which aims to introduce from the start communication and collaboration between health profession students
Practice Qiroah and Worship	Discussing good and true worship, funeral care as well as discussing the basics of reading the Qur'an properly and correctly, memorizing short surahs and selected surahs

Indonesian	Studying Indonesian for the purposes of written and oral communication in accordance with the rules of good and correct academic writing which an academic must have, the importance of Muslim nurses learning the language both spoken and written and as a means of improving the communication competence of Muslimnurses by taking ibrah from the story of Rasulullah Zaid's friendbin Thabit

Basic Nursing Science	Discusses the concepts of pathology, pathophysiology, microbiology and parasitology in various conditions as a basis for studying advanced science and its perspective in Islam.
Nursing Pharmacology	Discusses the concept of pharmacology in nursing and the impactof drugs on body systems as a basis for studying advanced sciences or skills. Islamic integration: Thibbun Nabawi, rukhshah in medicine,expert in Islamic medicine. Including discussing medical etiquette in Islam including the MUI

Fulfillment of Basic Human Needs	<p>This course discusses the concepts, principles and clinical skills of nursing to help meet various human needs (activity and exercise, oxygenation, fluids, nutrition, elimination, comfort, cleanliness and self-care), the position of basic human needs (eg Henderson, Abraham Maslow) in the context of the most basic human needs in the Islamic view (1. The need to protect religion, 2. Protect yourself, 3. Moral needs, 4. Protect offspring, 5. Protect property) including the integration of qauliyah and kauniyah verses in every discussion</p>
Nursing process and critical thinking	<p>Discusses the concept of critical thinking of a Muslim nurse, the function of reason in Islam, thinking as worship, the prophet Ibrahim's faith in critical thinking, the concept of critical thinking in nursing and the nursing process of assessment, diagnosis, planning, action and evaluation.</p>
Pancasila	<p>Discusses Pancasila as one of the pillars of Indonesian nationality, the foundation of the state, national ideology, as a reference and inspiration for responding to the challenges of national life, the relevance of Muslim nurses understanding and implementing Pancasila in nursing service practice and understanding the harmony of Pancasila in Islam.</p>
Semester 3	
Psychosocial and Cultural in Nursing	<p>Discusses concepts in general and from an Islamic perspective regarding: psychosocial in nursing practice which includes self-concept, spiritual health, sexuality, stress adaptation and the concepts of loss, death and mourning, theoretical concepts of health anthropology which includes discussions related to culture in general, hospital culture, The etiology of disease is viewed from culture and perceptions of health and illness as well as culture-based responses to health and illness. Apart from that,</p>

	<p>it also discusses transcultural theoretical concepts in nursing which include transcultural perspectives in nursing, theory <i>culture care Leininger</i>, cultural studies and the application of transcultural nursing to various health problems and throughout the human life cycle. Including Islamic views in responding to cultures that support and do not support health.</p>
Nursing therapeutic communication	<p>Discusses the principles of therapeutic communication in general and from an Islamic perspective along with their application in the context of health services in general and specifically in providing nursing care intended for individuals, groups, families and communities for various settings, both clinical and community practice, the communication etiquette of Muslim nurses.</p>
Nursing Fiqh	<p>The nursing Fiqh module is a learning process that focuses on Islamic laws that will be applied by nurses in providing nursing care to Muslim patients from the fetus in the womb until death.</p>
Adult Nursing I (cardiovascular, respiratory and hematological systems)	<p>Discusses meeting the needs of adult clients with impaired oxygenation, circulation and hematology needs. Providing nursing care in cases of respiratory, cardiovascular and hematological disorders is based on the nursing process by applying biomedical knowledge such as biology, histology, biochemistry, anatomy, physiology, pathophysiology, medical surgical nursing science, internal medicine, pharmacology, nutrition, surgery and rehabilitation. These system disorders include inflammatory disorders, degenerative disorders, malignancy and trauma which are included in the 10 largest cases locally, regionally, nationally and internationally. The scope of discussion starts from assessment to evaluation of client care. Nursing interventions include nursing modality therapy for various conditions including complementary therapy as well as integrating qauliyah, kauniyah and fiqh views</p>

	on each subject
Basic Nursing Skills	Discusses nursing procedures which are the scientific basis for nursing practice which include vital signs, basic assessment and physical examination, infection control, medication administration procedures, as well as Islamic ethics in implementing nursing procedures
Maternity Nursing	Discusses efforts to improve the reproductive health of women of childbearing age, pregnant women, giving birth, postpartum, between the two periods of pregnancy and newborn physiology with an emphasis on preventive and promotive efforts using a nursing process approach by paying attention to legal and ethical aspects in clinical and community settings, as well as various discussions from relevant Islamic views (pregnancy process, practices when carrying a baby, carrying a baby, breathing in the human spirit, postpartum period, rules and sunnah for newborns: call to prayer, tahnik, giving good names, shaving hair, sunnah, breast milk , aqiqah, prayers for new born babies, etc.), including integrating qauliyah verses, kauniyah and fiqh views on each subject.
Nursing Information System	Explain and improve nursing students' abilities and practices regarding the concept and scope of nursing information systems, as well as Islamic views on the development of information systems, digitalization of health services
Citizenship Education	Discusses contextual issues of citizenship, develops positive attitudes and displays behavior that supports the spirit of nationalism and love of the homeland, supports civilized democracy, awareness of law and diversity, and the Koran as one of the foundations of citizenship education
Nursing English	Discusses basic English language skills, namely speaking, listening, reading and writing, including aspects of grammar and vocabulary within the scope of nursing services and work

Semester 4	
Reproductive Health Nursing	This course discusses efforts to improve the reproductive health of women of childbearing age, pregnant women, giving birth, postpartum, between two pregnancies in risky conditions and problems related to reproductive system disorders with an emphasis on preventive and promotive efforts using the nursing process approach and pay attention to legal and ethical aspects in clinical and community settings
Adult nursing II (endocrine system, immunology, digestion, urination and male reproduction) (LO 1,2,3,4,5,9)	The focus of this course is on meeting the needs of adult clients with disorders of the endocrine, immunological, digestive, urinary and male reproductive systems. Providing nursing care in cases of disorders of the endocrine, immunological, digestive, urinary and male reproductive systems based on the nursing process by applying biomedical sciences such as biology, histology, biochemistry, anatomy, physiology, pathophysiology, medical surgical nursing science, internal medicine, pharmacology, nutrition, surgery and rehabilitation. Disorders of this system include inflammatory disorders, degenerative disorders, malignancy and trauma, which are included in the 10 largest cases locally, regionally, nationally and internationally. The scope of discussion starts from assessment to evaluation of client care by paying attention to Islamic values. Nursing interventions include Nursing modality therapy in various conditions including complementary therapies.
Nursing for healthy and acutely ill children	This course is a nursing skills course that focuses on the response of children and families at every stage of development from neonates to late adolescence, whether in health

	<p>or acute illness, in the community or being treated in hospital, as well as nursing interventions both independent and collaborative. . This course is also an integration and application of basic nursing knowledge, basic nursing science and Islam which leads students to learn more about how to provide professional (holistic) nursing care, provide health education, carry out advocacy functions for clients and their families by implementing effective communication, and create decisions by considering legal and ethical aspects.</p> <p>Student learning activities are oriented towards achieving systematic comprehensive and critical thinking skills in applying concepts using the nursing process approach as a basis for solving problems and developing professional attitudes (development of <i>soft skills</i>) through several relevant learning models.</p>
Psychiatric Nursing	<p>This course discusses nursing care for clients who experience mental disorders, Islamic views on mental disorders, recovery from mental disorders with a holistic approach and person-centered care is the focus of this course, including therapeutic relationships individually and in the family context and implementation. nursing modality therapy including Islamic psychotherapy. Mental nursing care for special groups and clients who use drugs is also a topic of discussion in this course. This course also integrates Islamic views and Islamic therapy on psychosocial problems and mental disorders.</p>
Semester 5	
Adult Nursing III (musculoskeletal system, integument, sensory perception and innervation)	<p>Discusses meeting the needs of adult clients with disorders of the musculoskeletal system, integument, sensory perception and nervous system. Providing nursing care in cases of disorders of the musculoskeletal system, integument, sensory perception and innervation based on the nursing process by</p>

Nursing for chronic and terminally ill children	<p>This course focuses on the response of children and their families to every development from neonates to the end of adolescence, whether in conditions of chronic, terminal illness and special needs, in the community or being treated in hospital, as well as nursing interventions both independent and collaborative in accordance with Islamic principles.</p>
Dying and palliative nursing	<p>This course studies nursing perspectives and palliative care concepts, ethics, policies, techniques for delivering bad news, communicators, psychological needs of palliative patients, pain management, various types of complementary therapies, religious and cultural insights regarding chronic illness. Islamic integration: definition of death in Islam, preparation before death, signs of death in Islam, overcoming problems related to other people's deaths, meaning of death, benefits of remembering death), including janaiz fiqh</p>
Community Nursing Concepts	<p>This course discusses basic concepts of community health and nursing, health programs & government policies in dealing with priority health problems in Indonesia, community nursing care and discussions related to issues and trends in community health problems. This course is useful in understanding the basic concepts of community nursing and various special areas in community nursing, especially related to</p>

	health problems that commonly occur in Indonesia and understanding the mechanism for guaranteeing community nursing services, as well as issues/trends that occur and/or the prerequisites for taking community nursing courses. II. Islamic integration: the concept of society/community in Islam and the role of Muslim nurses in the health of the people
Research Methodology & Islamic Scientific Traditions	Discusses philosophy of science, research concepts, development of nursing research, research process, research dimensions, hypothesis testing selection procedures, descriptive statistics, hypothesis testing, comparative, categorical variable hypothesis testing, correlation testing, research proposals, research ethics, and writing research results. Islamic integration: Muslims' obligation to science, the Koran as a source of knowledge, the character of Muslim researchers, Islamic research methods, the role of Muslim scientists in the development of knowledge, especially in the health sector
TOEFL Preparation English	Learn the basics and practice of English for Toefl
Family Nursing	This course focuses on achieving students' ability to provide nursing care to individuals in the family and family context at various stages of family development and health problems that are common as the focus of care. The discussion includes concepts, theories related to family nursing practice, the family nursing process and ethical, cultural and Islamic aspects relevant to family nursing practice. Islamic integration: The concept of family in Islam, the purpose of having a family, stages of family development in Islam. Four types of families in Islam, the role of Muslim nurses in family health, as well as discussing family jurisprudence that is relevant to nursing practice
Semester 6	

Community Aggregate Nursing	<p>Focuses on aggregate community nursing care and addresses various issues and trends in community health problems in the context of primary health care with an emphasis on health promotion, disease prevention and health maintenance. The discussion also covers management in special areas in nursing, including school health nursing, occupational health, home care, quality assurance of community nursing services, trends in community nursing with an emphasis on health, disease prevention and health maintenance as well as identifying community-based interventions related to Islam</p>
Gerontics Nursing	<p>Discusses the basic concepts of gerontic nursing, gerontic nursing theory and nursing care in meeting the basic needs of the elderly, its application to nursing care regarding the bio, psycho, social and spiritual needs of the elderly targeting individuals, families and groups/communities. In addition, this course discusses Islamic views on aging and the elderly and the human obligation to be kind to the elderly.</p>
Nursing Leadership and Management	<p>This course studies how to manage a group of nurses using management roles and functions in order to provide nursing care to clients in a nursing service setting at the ward level in a hospital. Develop collaborative skills in achieving organizational goals and apply leadership concepts, management roles and functions. Emphasis on the topic of the role and function of the nursing unit manager. Islamic integration: humans as caliphs, especially nurses as caliphs in their field, the concept of leadership in Islam, Muslim nurses must be able to become leaders and managers. Islamic leadership concept, Ibrah from the leadership of the Prophet Muhammad SAW, postulates about leadership.</p>
Emergency Nursing	<p>Discusses the concept and planning of</p>

B. Study Load, Study Duration, Student Status

Study Load

The total study load for students enrolled in the Nursing Science Study Programme is 146 credit units. This credit structure is designed to ensure the achievement of the intended learning outcomes and compliance with national higher education standards.

Study Duration

All students **at** Syarif Hidayatullah State Islamic University Jakarta are required to complete their studies within the prescribed duration in accordance with applicable legal and institutional regulations:

Undergraduate students complete their studies in a minimum of four (4) years and a maximum of 7 (seven) years;

C. Student Status

Based on the duration and continuity of study, students at Syarif Hidayatullah State Islamic University Jakarta are classified into the following categories:

1. *Active Students*: Students who are officially enrolled, re-register each academic term, and fulfill tuition payment requirements.
2. *Inactive Students*: Students who do not re-register and do not fulfill tuition payment obligations during a given academic period.
3. *Students with Terminated Study Status (Dropout)*: Students whose study status is terminated due to academic performance below the minimum cumulative grade point average (CGPA) of 2.00, exceeding the maximum permitted study duration, or being subject to institutional sanctions in accordance with university regulations.
4. *Graduated Students*: Students who have successfully completed all academic requirements and are formally awarded their degree.

VENUE OF PRACTICE

To support the achievement of graduate competencies, the Nursing Science Study Program is equipped with several laboratories, such as an Emergency Nursing Laboratory, a Community Nursing Laboratory, a Medical–Surgical Nursing Laboratory, a Maternity Nursing Laboratory, a Pediatric Nursing Laboratory, a Mental Health (Psychiatric) Nursing Laboratory, a Gerontological Nursing Laboratory, and a Basic Nursing Skills Laboratory.

2.7 Learning System

2.7.1 Basic Definition

This section outlines the fundamental definitions applied within the Semester Credit System. A semester represents the smallest standardized unit of academic time used to structure and measure the teaching and learning processes of an educational programme. Accordingly, the organization of the curriculum from commencement to completion is arranged into semester-based learning activities. At the beginning of each semester, students are therefore required to plan and register for their academic activities for that period.

One semester is equivalent to approximately sixteen (16) instructional weeks and concludes with a final semester examination. An academic year consists of two regular semesters, commonly referred to as the odd and even semesters, which together constitute the annual academic cycle.

Semester Credit Units /*Satuan Kredit Semester* (SKS) are units used to indicate:

1. The amount of student study load.
2. The recognition of students' learning efforts.
3. The effort required by students to complete a program,

whether it's a semester-based or full program.

4. The effort required for educational delivery by the instructors.

The course load refers to the number of credit units undertaken by a student in a given semester. In contrast, the cumulative study load denotes the minimum total number of credits that a student must successfully complete in order to be considered as having fulfilled the academic requirements of a specific study programme.

The cumulative study duration represents the maximum time limit within which students are required to complete their studies in an educational programme. For the Bachelor of Nursing Science Study Programme, the minimum cumulative study load is set at 145 credit units (equivalent to 244 ECTS), which is normally completed over eight semesters, with a maximum allowable study duration of fourteen semesters.

One Semester Credit Unit (SKS) for lecture-based courses is defined as the standard weekly study load throughout a semester and comprises the following three components of academic activity:

1. One hour (50 minutes) of face-to-face interaction.

2. One hour (60 minutes) of structured assignments.
3. One hour (60 minutes) of independent work."

One SKS (Semester Credit Unit) seminar activity is primarily based on lecture activities (item 1). The number of references used and summarized for presentation in front of the forum is a minimum of 3 (three) titles, depending on the weight of the references. One SKS of laboratory practical activity is determined to be equivalent to a study load of about 170 minutes of scheduled laboratory work, accompanied by:

1. The course instructor planned 1-2 hours of structured activities, including discussions, seminars, literature studies, laboratory/field research, and participation in an institution.
2. 1-2 hours of independent activities, including searching for books/journals in other libraries, preparing research, and writing the thesis/final assignment.

The learning process is conducted using student- centered learning (SCL) methods, which are adapted according to the policies of each study program, including problem-based learning, role play, simulation, mini-lectures, e-learning, and group discussions.

2.7.2 Student Registration

Every student admitted and registered at UIN Syarif Hidayatullah Jakarta is required to be familiar with the academic program they are enrolled in. Therefore, every student must carry out the following:

Re-registration and Study Plan Submission

At the beginning of each semester, students are required to complete re-registration and submit their study plans through the Academic Information System (AIS). Failure to do so will result in the student's status being changed to "Non-Active," and their rights as a student for that semester will not apply. To be able to attend classes in the following semester, the student must re-register by fully settling their financial obligations for the current semester and any outstanding debts from previous semesters. The semester in which a student's status is "Non-Active" will still be counted as part of their overall study duration.

e-RS (Electronic Study Plan) submission is subject to the following conditions:

- a. Students in their first semester (semester I) are only allowed to take courses designated for that semester. Students in subsequent semesters can take courses as stipulated.
- b. Students must pay attention to compulsory and elective course groups.
- c. Sequential or prerequisite courses must be taken in the prescribed order.
- d. The number of courses and their corresponding credit load must adhere to the applicable regulations, taking into consideration the semester's grade point average and the maximum allowable credit load.
- e. Students are allowed to take cross-disciplinary courses within the university as long as the course content, nomenclature, course codes, and alignment with the discipline packages of the student's program of study are met.

Throughout their academic journey, students must re-register and submit a Study Plan each semester (including thesis/dissertation and selecting an academic advisor for each semester)

Re-registration and Study Plan Submission

At the beginning of each semester, students are required to re-register and submit course plans. If they fail to do so, they are automatically deemed to have suspended their studies and entitlements due to student invalidation. In turn, to take classes in the following semester, they need to re-enroll by paying financial obligations for the current semester as well as the previous one. Please advise that the duration of study in the semester in which they fail to take counts as the duration in their overall completion of studies.

The following conditions apply to the submission or submission of lecture plans during re-registration:

1. Students in semester 1 are only permitted to take the courses allotted to the semester, however they may take them in later semesters according to requirements.
2. Students pay close attention to mandatory and elective courses.
3. Continuing or prerequisite courses are taken in the order specified.
4. In taking the number of lectures and load of credit points, students refer to the applicable regulations by considering their GPA as the minimum maximum number of credit points required.

5. Students are permitted to take lectures in cross-study programs within the university as long as the program substance, their nomenclature, and their program code conform to the disciplinary package in the study program the student is taking;

Students may take programs in cross-study programs with external universities as long as the substance of the programs, their nomenclature, and their program codes are in line with the disciplinary package in the study programs taken by students, and an MoU between the two involved the chancellor is made.

Change of Study Plan

According to the academic calendar, changes, substitutions, and course cancellations can be made during the e-RS input schedule. Suppose the Academic Advisor has validated the e-RS, but the student wishes to change or cancel courses. In that case, the process can be carried out after approval by the Academic Advisor as long as the e-RS input schedule has not been closed.

Undergraduate Thesis

Seminar Registration Procedure and thesis seminar registration are conducted online through Google Forms

1. Thesis Seminar Registration: The department (Prodi) will arrange the schedule and select examiners.
2. Students are required to submit their proposal or thesis to their advisors and examiners at least two days before the seminar.

Requirements for Students Eligible to Conduct Proposal Seminars:

1. Fill out the proposal seminar registration Google Form.

2. Enroll in the proposal seminar course in your Study Plan (KRS). (Proven by attaching the KRS, signed by the Academic Advisor.)
3. Have completed a minimum of 135 credit hours. (Proven by attaching an official transcript, initialed by the Academic Advisor.)
4. Obtain approval from Advisor. (Proven by attaching a statement of approval from the advisor.)

Requirements for Students Eligible to Conduct Bachelor Thesis Seminars:

1. Create a letter of request to the Program Coordinator (using the provided form) and fill out the thesis seminar registration Google Form.
2. Obtain approval from your advisors to conduct the Final Examination (the approval sheet in the thesis should be signed by both Advisor).
3. Have passed all courses with a minimum grade of C. (Proven by an official transcript, with a total of 142 credit hours, initialed by the Academic Advisor.)
4. Enroll in the Thesis course (4 credit hours) and Comprehensive Seminar (1 credit hour) in your Study Plan (KRS). (Proven by attaching the KRS.)
5. Have completed all administrative requirements at the faculty (such as tuition payment, etc.), proven by official letters or receipts.
6. Submit six thesis bundles approved by the advisors and the program coordinator.

7. Engage in the thesis advisory process with your advisors (proven by a thesis advisory book with a minimum of 10 meetings with both advisors during the thesis process).
8. Have a minimum TOEFL score of 450 (proven by the original certificate and a photocopy, legalized by an authorized official).
9. Have a minimum TOAFL score of 375 (proven by the original certificate and a photocopy, legalized by an authorized official).

Requirements for Participating in the Comprehensive Examination:

- a. Create a letter of request to the Program Coordinator (using the provided form) and complete the comprehensive examination registration Google Form.
- b. Obtain approval from your advisors to conduct the final examination (proven by an official/original statement from the advisors).
- c. Students have passed the thesis seminar.

Procedure for Submitting Grades for Student Proposal Seminars, Bachelor Thesis, and Comprehensive Examinations at the UIN Syarif Hidayatullah Jakarta:

1. Students participating in the seminar should download one of the official report forms corresponding to the seminar's type, along with the assignment letter. These report forms and assignment letters can be downloaded from the following links:
 - a. Proposal Seminar.
 - b. Thesis Seminar.

2. Students participating in the seminar should also download the assessment matrix corresponding to their seminar type and provide it to each examiner and advisor:
 - a. Assessment Matrix for Proposal Seminar
 - b. Assessment Matrix for Result Thesis Seminar
 - c. Assessment Matrix for Thesis Seminar
3. Students should submit the completed report form to their advisors and request them to return the report form and assessment matrix to the program coordinator, signed by each examiner and advisor.

Procedures for Conducting Proposal Seminars, Thesis Seminars, and Comprehensive Seminars:

1. The seminar duration is set for 60 minutes (1 hour).
2. The time allocation for conducting proposal seminars and thesis seminars is as follows:

TOEFL AND TOAFL SCORE

As one of the graduation requirements for the Bachelor program, the Chancellor has issued Rector's Decree No: Un.01 / R / HK.005 / 233/2012 which sets standard English or Arabic achievement scores for students at Syarif Hidayatullah State Islamic University. The minimum TOEFL passing score is 450 and TOAFL = 375.

Center for Language and Culture (Center for Language and Culture / PPB) is an institution that organizes TOEFL and TOAFL tests at Syarif Hidayatullah State Islamic University. In addition, PPB also has the authority to issue certificates for students who have taken the test as proof of their passing scores. However, English or

Arabic test scores (institutional or international) from other institutions may be accepted if approved by the Language Centre.

Assessment of Learning Outcomes

Evaluation of learning outcomes includes structured assignments (Formative), Mid Semester Exams (UTS), and Final Semester Exams (UAS) according to the university's academic calendar except for the Nursing Science Study Program which uses a Module system. Requirements to take part in UTS and UAS if students meet a minimum attendance of 80%. Provisions regarding the final score of the evaluation of learning outcomes is determined by the choice of the applicable weighting model. Students who cannot take the exam due to illness or other reasons must ask permission from the Head of the Study Program. Follow-up exams must be carried out no later than 7 (seven) days after the scheduled exam and carried out no later than 1 (one) month after the scheduled exam. Learning outcomes assessment instrument adapted to the characteristics of learning outcomes

Assessment of the entire study load taken by students in one semester is carried out at the end of the semester. The results of the assessment are known as the Grade Point Average (GPA) and the Grade Point Average (GPA). Basically, the assessment includes

several components such as student attendance, presentations, formative tests, mid-term assessment, practicum and/or other assignments, and final assessment.

Assessment of the results of the course exams and writing of scientific papers is done by giving a numerical value which is then converted to a letter grade that is given a weighted value. The conversion and value weights for the Undergraduate program of UIN Syarif Hidayatullah Jakarta are as follows:

In the last semester, due to several circumstances required in the way lectures are recorded in the lecture plan not given in the

semester, students are allowed to take other available lectures with the approval of their academic adviser and the Head of Study Program.

With acceptable reasons, undergraduate students who have been admitted for at least 2 (two) semesters are granted permission to leave for one (1) semester or two (2) semesters above during their studies. To ensure the quality of their studies, they are expected not to take consecutive days off. Please note that this leave of absence is counted in the study period. During their leave, they are only required to pay administrative fees stipulated by the Chancellor's regulations. Here, requests for leave are submitted to the Chancellor c / q Head of the Academic, Student Affairs and Cooperation Administration Bureau no later than 7 (seven) days before re- registration for the following semester.

Students must attach the following documents before taking leave:

1. Proof of enrollment in the current semester.
2. Recent student achievement records.
3. Approval letter from the Academic Advisor and/Study Program.

If the requirements are met, the Chancellor, Head of the Academic, Student Affairs and Cooperation Administration Bureau will issue a leave letter in which a copy of the letter is submitted to the Dean and the Ministry of Finance. In turn, they are required to pay administrative fees for leave at the Ministry of Finance as determined by the Chancellor's regulations. Furthermore, a letter authorized by the Chancellor, Head of the Bureau of Academic

Administration, Student Affairs, and Cooperation and proof of payment of administrative fees is submitted to Academic Affairs as proof of student registration.

Students who have taken leave for one (1) or two (2) semesters are required to re-register in the following semester by fulfilling all academic and financial administration requirements as stipulated and attaching a leave of absence letter obtained in the previous semester.

Withdrawal

Students who wish to withdraw from UIN Syarif Hidayatullah Jakarta can follow the withdrawal procedure as follows:

- a. The concerned student submits a written request to the Dean of the faculty / Director of the Graduate School with approval from the Program Study.
- b. The faculty / Graduate School submits this request to the University Rector through the Head of the Academic Administration and Student Affairs Office (Biro AAKK), along with Proof of tuition fee clearance from the Finance Department and library clearance.
- c. The University Rector, through the Head of the Academic Administration and Student Affairs Office (Biro AAKK), issues a Withdrawal Certificate with an attachment of the Study Results Recapitulation.

Academic Advisor

Establishing a credit system as an educational system allows students to plan and decide on the courses they will take each semester. In course planning and selection, students are advised to consult with their academic advisors. However, the final decision is

the responsibility of the students themselves. A student's success in their studies is not solely based on their academic abilities but can be influenced by various factors. Academic advisors serve as guides or counselors to students in addressing academic and non-academic issues.

The responsibilities of academic advisors include:

1. Assisting students in recognizing and identifying their interests, talents, and academic abilities.
2. Guiding students in selecting courses each semester to ensure they can effectively and efficiently utilize their study time.
3. Providing motivation for students to find solutions and the best possible approach when facing problems.
4. Assisting students in preparing and developing their study plans and validating study plans (e-RS) entered into the AIS based on their interests, talents, and academic abilities.
5. Verifying and validating the SKPI (Certificate of Accompanying Diploma) for students.
6. Providing consultation to students in the preparation of research proposals for their final projects/theses.

Yudisium, Graduation of Students, and Commencement

1. Yudisium Yudisium is the determination of whether a student has passed or not, serving as the final assessment process for all courses undertaken, including the defense of the final project/thesis/dissertation along with any revisions.
2. The determination of graduation is conducted during an academic meeting by the Dean of the faculty or the Graduate School and is announced to the students.

3. Yudisium can be conducted one month after the defense of the final project/thesis/dissertation and several times before the commencement ceremony.
4. Students who have completed their final project/thesis/dissertation defense and have received approval for any revisions must register for yudisium to request their graduation.
5. The requirements for registering for yudisium are as follows:
 - a. Completion of all required courses and meeting the minimum credit and GPA requirements according to the educational program.
 - b. Successful Completion of the munaqosah/examination of the final project/thesis/dissertation, as documented in the official report.
 - c. Possession of a report on the submission and approval of the final project/thesis/dissertation, signed by the Dean, Chair of the Program Study, examiners, and advisors.
 - d. Clearance of tuition fees, confirmed by a certificate from the university's finance department.
 - e. Clearance of library obligations, confirmed by a library clearance certificate from the university and faculty. Yudisium is signed by the relevant faculty dean.
6. The date of the Yudisium Certificate represents the student's graduation date.
7. The faculty dean reports the graduation of students in writing to the University Rector or the Vice Rector for Academic Affairs no later than 10 days after the designated date

PART III ACADEMIC SANCTIONS

3.1 Administrative Sanctions

Students who violate the provisions of academic administration receive the following sanctions:

1. Fines apply to students who register late according to the schedule provided with the following criteria:
 - a. One to six days, 10% of the overall tuition fee.
 - b. Seven to thirteen days, 20% of the overall tuition fee.
2. Students who fail to register no later than 13 days after the designated enrollment period must apply for academic leave.
3. If for some reason they are unable to apply for leave, the University will consider them as students on leave.
4. Students who do not register in the previous semester without reason are charged tuition fees for that semester and a fine of 50% of the total tuition fees, and are required to pay tuition fees for the following semester including late fees.

3.2 Academic Sanctions

1. Students who do not register in two consecutive semesters receive sanctions in the form of study termination (dropout from the University).
2. Students who fail to submit course plans according to the timetable provided are not eligible to join the class. For example, if they take an exam, the score they get is invalid.
3. Students whose attendance is less than 75% of the total attendance in certain lectures in one semester are not allowed to take the exam and automatically fail the lecture.

4. Students who do not complete structured and/or independent assignments will be penalized for lateness or cancellation of the grades they get by the lecturer concerned.
5. Students who get a GPA of less than 2.00 in semester 2, semester 4, semester 6 or semester 8 will be expelled.
6. Students who have exceeded the maximum duration of study (10 semesters) without an acceptable reason and have not completed their studies will be automatically expelled.
7. Students who are unable to complete the necessary revisions to their final year project after the exam within three months of the exam, their final year project grade will be canceled and replaced with the one from the next exam.
8. Academic sanctions are proposed by the Faculty team and forwarded to the Chancellor by the Dean to issue a Decree regarding the termination of studies.
9. Students who have received a study stop are not allowed to take any studies at Syarif Hidayatullah State Islamic University.

3.3 Non-Academic

Students who break the provisions of academic, legal, and moral offenses shall face the punishments listed below.:

1. Reprimand Letter;
2. Warning Letter;
3. Suspension for a certain period of time;
4. Drop out.

The sanction is determined by the Chancellor's decision which refers to the University Senate's proposal after considering recommendations by a special team consisting of various

elements from both the faculty and university. Therefore, termination of studies for non-academic reasons is only authorized by the Chancellor based on the University Senate meeting

3.4 Graduation

1. Students who have successfully completed their studies at Syarif Hidayatullah State Islamic University are officially given a graduation ceremony with the following procedure:
 - a. The graduation ceremony is officially given by the Chancellor;
 - b. Graduation ceremonies are held four times a year;
 - c. Graduates use attributes in accordance with applicable regulations at the University;
 - d. The Scholarship Pledge is led by a graduate and is followed by all graduates.
2. Students who have won the Cum Laude (Mumtaz) academic award are entitled to be the best graduates.
3. The list of the best graduates is proposed and submitted by the Dean of each faculty for approval by the Chancellor.
4. If there are two or more students who are entitled as the best graduates in a particular faculty, they are determined as follows:
 - a. Test scores from each candidate's last year's project;
 - b. Core course scores;
 - c. Non-academic achievements of the candidate;
 - d. Study duration.

3.5 Certificate

1. Students who have completed their studies are awarded a certificate as proof that they meet the academic requirements and are given a graduation ceremony.
2. Requirements for certificate claims:
 - a. Exemption letter from hostel.
 - b. Exemption letter from the library (Main and Faculty libraries).
 - c. Transcript issued by the Faculty / Department / Study Program.
 - d. Final year project submission letter.
 - e. Financial release letter.
 - f. Exemption letter for loan.
 - g. Nursing professional students are entitled to receive a professional certificate after being declared to have passed the Indonesian Nurse Competency Test.

PART IV FACILITIES

The facilities available in the Nursing Science Study Program and Nurse Profession Study Program at UIN Syarif Hidayatullah Jakarta are as follows:

1. **Library:** The Faculty of Health Sciences has access to a library with a collection of physical and electronic books and scientific journals. Students can also access digital library resources, making research and study more convenient.
2. **Internet Access:** High-speed internet access is available to all Faculty of Health Sciences academic members.
3. **Classrooms: Faculty have** classrooms that are equipped with modern facilities, including air conditioning, LCD projectors, whiteboards, and microphones.
4. **Laboratories:** basic nursing skills laboratory, medical surgical nursing laboratory, emergency and critical care laboratory, operating room laboratory, maternity nursing laboratory, , pediatric nursing laboratory, psychiatric nursing laboratory , community nursing laboratory and family nursing laboratory,
5. **Toilet Facilities:** Restrooms are conveniently available for students and faculty.
6. **Prayer Room (Musholla): the room that is** dedicated prayer room for religious and spiritual needs.
7. **Cafeteria:** There is a cafeteria for students to enjoy meals and snacks.
8. **Computer Facilities:** Computer labs with internet access for academic and research purposes.
9. **Lecture Halls:** Spacious venues for lectures, seminars, and conferences.

10. **Student Activities:** Facilities for student meetings, discussions, and other extracurricular activities.

11. **Wi-Fi Access:** Campus-wide Wi-Fi connectivity for students to access the internet.

12. **Recreation Facilities:** Areas for relaxation, socializing, and leisure activities.

13. **Parking :** Parking areas for students who commute by car.

Additionally, the university offers various other facilities, including the main library, central mosque (masjid), health facilities, more dining options (kantin), and a central library that can be accessed by students. Students can also access facilities in other locations, such as hospitals for their Fieldwork Practice.

These facilities collectively contribute to creating a conducive learning environment and supporting the academic and non-academic needs of students within the Nursing Science Study Program and Nurse Profession Study Program at UIN Syarif Hidayatullah Jakarta.

PART V COLLABORATION IN EDUCATION, RESEARCH AND COMMUNITY ENGAGEMENT

5.1 Collaboration in the Field of Education

The Faculty of Health Sciences at UIN Syarif Hidayatullah Jakarta has expanded its educational reach internationally through synergistic international collaborations, including international joint research, conferences, and publications. PART VI STUDENT AND ALUMNI

6.1 Students

The main goal of student development in the Nursing Science Study Program at UIN Syarif Hidayatullah Jakarta is to support and complement curricular activities with extracurricular activities.
